THE MARQUIS AWARD

Established in 1990, *Marquis Awards* are presented annually to individuals or organizations that have demonstrated leadership in the implementation, advancement or awareness of ACH payments; or have exhibited long-standing support and contributions to the EPCOR mission.

- Has your organization implemented forward-thinking financial products- such as a P2P service or mobile application for your customers or members?
- Have you developed or championed practices instrumental in the advancement of ACH Payments, such as implementing the Federal Reserve's Same-Day ACH product or offering an ACH credit solution to small businesses?

This award is named after the late David P. DeMarea, longstanding EPCOR Director and Senior Vice President of ARVEST Bank Operations.
